The Choir of High Hopes Hobart Inc (Choir) is a volunteer run, not for profit charity for people disadvantaged by homelessness, unemployment, drug and alcohol issues, mental and physical disabilities, injustice and social and economic isolation. The Choir provides a haven, a place of learning, discovery and tolerance, of improved self-esteem and hopes for a brighter future.

Purpose

We are committed to safeguarding your privacy and ensuring the security of your personal information. This Privacy Policy outlines how we collect, use, and protect your data when you interact with us, whether it's through our website, events, or other communication channels. By engaging with the Choir, you agree to the terms outlined in this Privacy Policy.

Information We Collect

We may collect various types of information, including but not limited to:
